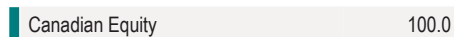

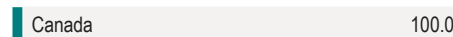
How is the fund invested? (as of April 30, 2026)



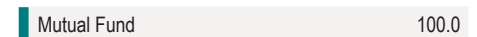
Asset allocation (%)



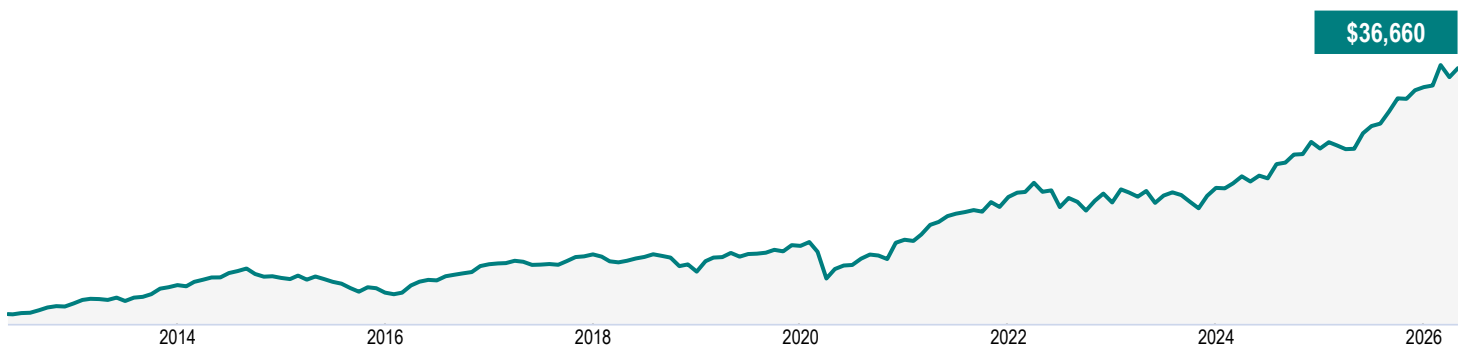
Geographic allocation (%)
